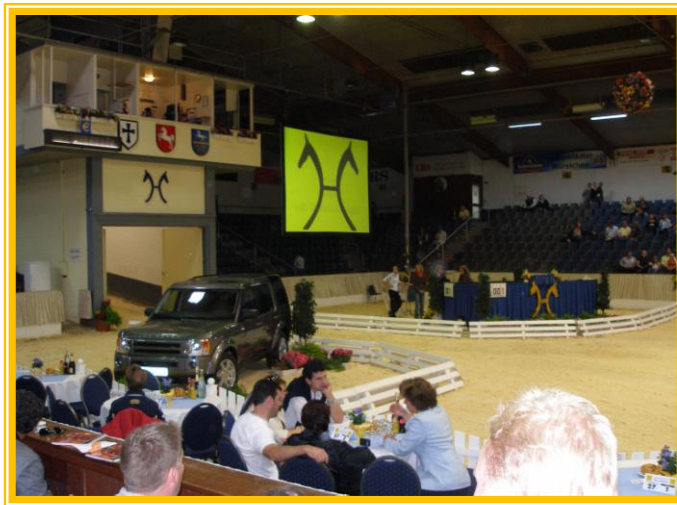

1. Introduction

At the recent inaugural International Meeting of Hanoverian Breeding Clubs and Daughter Societies in Germany, members of the Hannoveraner Verband and other Daughter Societies from around the world expressed their admiration for the exciting and progressive work of the Hanoverian Horse Society of Australia. The project involves our Society assisting members to select and purchase 20 fillies from the annual Hannoveraner Verband e.V Elite Auction of Foals and Broodmares in Germany and importing these 20 fillies into Australia. We are delighted that you are interested in being part of this historic event!

As our Australian breeders already produce Hanoverians that are of international quality, the main purpose of this Project, therefore, is to broaden the gene pool of the Hanoverian population in Australia. Participants are encouraged to consider purchasing fillies whose bloodlines are not available in Australia, such as those by a stallion whose semen does not freeze, therefore limiting the addition of these genetics to our Australian Hanoverian population. Whatever the reason for importing a filly foal, the Society can assist you. Together with the support of the Hannoveraner Verband, we have been able to negotiate discounts and professional expertise unparalleled in the history of our Society, or in fact, Australian breeding history. This is a once in a lifetime opportunity to be involved with an innovative Society whose only interest is to assist you with the purchase and importation of a new filly foal. Let us help to make your dreams become a reality.

2. Overview

The Hanoverian Horse Society of Australia Inc. implemented this exciting proposal as part of its “500 in 5” marketing program to enhance the breeding programs and broaden the gene pool of the Hanoverian population in Australia. The thought of importing a horse is something many owners and breeders consider, but the costs and the complexities of importation can be prohibitive. The Hanoverian Horse Society of Australia has acted upon an innovative idea to assist its members in achieving this dream.

This proposal will operate in 3 different ways:

1. An agent will be provided on behalf of members to select and bid on foals on behalf of a member; or
2. Members may select and bid on foals themselves; or
3. Members may select a foal and have the agent bid on their behalf.



A total of 20 fillies will be purchased under this proposal from the Hannoveraner Verband e.V 35th Elite Auction of Foals and Broodmares, 21 to 23 August, 2009. Guido Klatte & Co, in conjunction with Crispin Bennett International Horse Transport Pty Ltd, has been engaged to attend to the necessary vaccination, blood testing, transportation and quarantine requirements for these 20 fillies. Thus, members have the opportunity to secure a world class filly without having to leave home!

With prices at the 34th Elite Auction of Foals and Broodmares 2008 starting at \$2,500(Euro) there were some stunning foals for sale at very reasonable prices. The table below will give interested people an idea of the price range that these foals sold for:

3. Terms and Conditions

3.1 Purpose of Proposal

The purpose of this proposal is to enable current and future members of the Hanoverian Horse Society of Australia to participate in a project implemented by the Hanoverian Horse Society of Australia for the purchase and importation of Hanoverian filly foal/s (only) from the Hannoveraner Verband e.V 35th Elite Auction of Foals and Broodmares, 21 to 23 August, 2009.

3.2 Selecting Your Filly Foal/s

Participants in this scheme will be asked to pre-select their filly foal/s preferences from the Hannoveraner Verband e.V 35th Elite Auction of Foals and Broodmares, 21 to 23 August, 2009 catalogue and detail the amounts (in Euros) they are willing to have bid on their behalf for said filly foal/s.

The auction catalogue will be uploaded to the Verband's website (www.hannoveraner.com) on 26 July 2009. Foal details, including video footage of some of the foals, can be viewed at this site. We will also have a selection of DVD's and hard copies of the auction catalogue to distribute to participants.

A form, in which participants will need to detail which filly foal/s you wish to bid for, is included in this proposal under Documents. This completed form will need to be received by the Hanoverian Horse Society of Australia by Monday 10 August 2009.

The Hanoverian Verband has agreed that:

- Should the collective number of fillies purchased under this scheme be 15 or more (up to 20) then the commission charged by the Hanoverian Verband will be reduced from 6% to 3%.
- Should the collective number of fillies purchased under this scheme be 20 or more then the commission charged by the Hanoverian Verband will be reduced from 6% to 1%.
Refer 3.4 Condition of Sale – Foals – C. Settlement and Payment for further detail on the commission.

3.3 Authorised Agent

The Hanoverian Horse Society of Australia has engaged a suitably experienced person from the Verband to bid on behalf of participants purchasing filly foal/s at the Hannoveraner Verband e.V 35th Elite Auction of Foals and Broodmares, 21 to 23 August, 2009 and under this proposal. This person will be provided with details of participants Lot number preferences and maximum bid amounts.

Alternatively, participants may wish to bid themselves should they be visiting the auction or via telephone. NB. In order to bid via telephone you will need to contact the Hanoverian Verband Auction Office and make the necessary arrangements.

3.4 Conditions of Sale – Foals

These Condition of Sale – Foals are those of the Hannoveraner Verband e.V., Lindhooper Straße 92, D-27283 Verden (Aller) and as prescribed for their 35th Elite Auction of Foals and Broodmares, 21 to 23 August, 2009

A. General

The Hannoveraner Verband e.V., Lindhooper Straße 92, D-27283 Verden (Aller) (herein after referred to as “the Hanoverian Association”) is the organizer of the auction and sells the foals described in the catalogue in its own name on vendor’s account (commission business). The purchase contracts under this condition shall be governed by German Law. Place of jurisdiction shall be Verden/Aller.

B. The Auction

The auction is a public event, lead by a public appointed and sworn auctioneer.

Tickets are available for everyone (as long as stocks last).

Since the risk of material defects is unpredictable for animals from birth, the foals will be auctioned off as second hand goods. The regulations of selling consumer goods (SS474 ff German Civil Code) cannot be applied.

Provided the buyer is a consumer according to S13 German Civil Code, the foals will be sold as “new” and instead of the regulation mentioned under paragraph E, b-h, the regulation as laid down under E, i, will apply.

The foals will be offered for sale in EURO. Bidding will begin at Euro 2,500.00. Only bids of at least Euro 200.00 will be accepted.

Should any doubts arise as to the validity of the knock-down price, this should be claimed at once, and the offer for sale can be taken up again. It is also allowed to announce doubts about the validity of the knock-down if the purchase note has already been signed, at the latest after the last foal of the auction was knocked-down. Only bidders, the auctioneer or the auction management are allowed to raise an objection. A commission consisting of the



managing director of the “Verband Hannoverscher Warmblutzuchter e.V.”, the auction manager or the auctioneer can decide on all objections. Only unanimous decisions can reverse an accepted bid.

If the buyer does not sign the purchase note or makes known during the auction that he will not take the foal, the commission can decide to put it up for the auction again. The first buyer is liable to the Hanoverian Association and to the vendor for any possible reduction in price.

C. Settlement and Payment

For its activity as a commission agent, the Hanoverian Association raises a commission fee. The amount to be paid depends on the knock-down price. Additional handling fees and taxes will be charged as well. The payment is due immediately upon adjudication. Foreign customers have to pay the fee for official veterinarian services.

The payment has to be effected in the auctioneer's office, either in cash or by means of a cheque. Foreign customers are allowed to pay cash only or in accordance with a prior agreement or another guarantee of payment, as agreed upon with the Hanoverian Association before. Cheque collection fees and interests are at remitter's (buyer's) charge.

The buyer's liability is definitively discharged after final settlement of the cheque. Stop payment orders against issued cheques are prohibited. The account will be rendered as follows:

Knock-down price

+ 6% commission

= Net amount

+ 7% VAT (acc. to S12(2) of the German Turnover Law)

= Settled price + 1% insurance (plus insurance tax, see also Clause 3.6)

= Final balance amount

The commission agent (the Hanoverian Association) insures all auction foals before. The new owners are the legal successors of each insurance contract after the lot went down. The insurance premium is settled with the auction invoice. According to S448 BGB (German Civil Code), the horses remain property of the sellers until full payment is effected. The "Verband Hannoverscher Warmblutzüchter e.V." is entitled to accept payment and to sue, in case of non-payment, the purchaser for the payment of the purchase price and all additional fees and expenses.

D. Sales Standards (Characteristics of the offered foals)

The following sales standards describe the necessary characteristics required for all auction foals. These characteristics are subject to buyer's legal rights. Details about the pedigree, sex, age, colour and – if available – special performances of the ancestors are the only characteristics fixed in this agreement. Photos and/or short statements published in the auction catalogue are only based on first impressions of the foal at the press date of the brochure. Neither the Hanoverian Association nor the exhibitor makes any assurance or evaluation in the sense of a guarantee of special qualities.

Current health problems or considerable changes of the catalogue descriptions will be announced by the auctioneer in the course of the auction.

The Hanoverian Association does not determine any additional characteristics. They are not subject of the contract.

E. Liability



All claims have to be directed to the Hanoverian Association. The Hanoverian Association is the commission agent and will settle all claims on exhibitor's behalf (principal).

The Hanoverian Association assumes the liability for the characteristics as agreed upon before in the sales conditions (section D) and in accordance with the legal regulations, however, with the following restrictions.

- a) Claims for later fulfilment or replacement are prohibited. Amendments are restricted to the report of the Veterinarian University in Hanover, stating that the healing of a disease is not to be expected with a period of six months of treatment. This report is binding for both parties.
- b) Claims for reduction are prohibited.
- c) Claims to withdraw from the contract: If – at the time of transition of liability – the foal's typical characteristics – as mentioned in the contract – are different from the ones the foal actually has, the Hanoverian Association is liable and has to accept a return of the foal and a repayment of the auction sales price.
- d) Claims for refunds. These claims are restricted to transport costs for the transport of the foal from the auction premises to the buyer's stable (within Germany only), regular costs for boarding and food, veterinary examinations, costs for the farrier and possible costs for necessary veterinary treatments in case of illness or injury. The seller is not liable for additional costs and compensations, replacements or loss of fortune, neither does he accept any training fees.
- e) Period of Notification: Claims for damages have to be directed to the Hanoverian Association, at the latest, within four weeks after transition of liability. The seller has to be informed about the faults "wind cribbing" and "head weaving" immediately, at the latest within two weeks after transition of liability.
- f) The Hanoverian Association and the exhibitor are only liable for the characteristics agreed upon. The foals are sold as inspected on the day of the action. Should the foal stay with the mare after the acceptance of the bid, it will be considered as being healthy upon transition of liability.
- g) The Hanoverian Association is not liable for the medical evidences and diagnoses of the veterinarians who have examined the foals before the auction.
- h) Buyer's claims for material defects are limited to a period of eight weeks following the transition of liability.
- i) Different to the regulations mentioned under b – h, the following applies for end users: The legal claims for damages will be valid.

Buyer's claims for compensation are excluded (compensation with service, compensation instead of service and replacements for expenditure). Excepted from this are buyer's claims for damages, resulting out of an impairment of life, body or health if the seller is responsible for the breach of duty and the liability for other damages, based on intention or gross negligence of the seller, his legal representative or his vicarious agent.

The claims loose validity two years after transition of liability.

F. Evaluations by the independent veterinarians

No guaranteed constitution

Apart from determining the basic characteristics, the Hanoverian Association sees to it that all foals offered for sale are examined by independent veterinarians prior to the auction. The exact details and the results of these examinations are fixed in a written report. This written report is at veterinarians' own responsibility and liability; neither the Hanoverian Association nor the exhibitor assumes any liability for these reports and the corresponding evaluations.

G. Removal and Transition of Liability

The buyer has to collect the foal from the vendor, at the latest, six months after date of birth at the exhibitor's domicile. On request and in case of collected shipping the foal will be delivered in Verden. However, should buyer and exhibitor agree on an earlier date, this is also permitted. The exhibitor bears the risk and the costs until the foal is weaned, including costs for the veterinarian and the farrier. Buyer and exhibitor have to agree on a removal date. At buyer's special request, the exhibitor is obliged to care for the foal for a period of approximately 8 weeks after date of purchase, however, at buyer's risk and liability.

(For the benefit of participants in this proposal, clarification on the above point was sought from the Hanoverian Verband and the following response was received:

Liability of the foals goes to the buyer on the 15th of October or earlier if the foal turns 6 months of age. In instances where the foal turns 6 months of age before the 15 October, the breeder must be willing to take care of the foal til the 15th of October, but the buyer will have to pay board.)

H. Alterations of Arrangements

The Hanoverian Association reserves the right to alter the auction arrangements or the regulation stipulated in this contract. In individual cases, different arrangements between single exhibitors and buyers are permitted. If any term or condition of these auction regulations is null and void or will become null and void, then all other terms and conditions shall remain in full force and effect. In fact of not being operative, the inoperative regulation should be exchanged against one which comes very close to the contract's purpose.

In case of doubt, the German version of the Conditions of Sale will be valid.

This Clause 3.4 is subject to change, as per the Hannoveraner Verband e.V 35th Elite Auction of Foals and Broodmares, 21 to 23 August, 2009 terms and conditions.

3.5 Paying for your Filly Foal/s

The Hanoverian Verband in Germany will invoice successful participants for their filly foal/s. Payment methods will be included with these invoices.

3.6 Insurance Coverage for Foals

When the bidding is concluded, all foals sold at the Verden spring auction will be insured by

A premium of 1% of the settled auction price will be paid to cover the insurance for a period of approximately 8 weeks from date of purchase of that particular year of birth, minimum until the foal is six months old:

- 80% of the foal's value if the animal dies or has to be put down due to illness or accident
- 80% of the value for permanent loss due to illness or accident

(NB: Before the filly turns 6 months of age the breeder will receive the 80% and the buyer will receive their money back. After the filly turns 6 months the buyer will receive the 80%)

No liability will be assumed for main vices.

Basis of the contract are the German General Insurance Conditions for horses and other equids (January 1995).

This coverage does also include:

- All transports within the aforementioned period of coverage (by land, air and sea) from Verden to the first buyer's stable.

The amount insured is based on the settled auction price, maximum EURO 25,000.00 plus commission and VAT.

- The Insurance contract will be concluded with the above mentioned company. The Hanoverian Society will bill the insurance premium with the final auction invoice.

This Clause 3.6 is subject to change, as per the Hannoveraner Verband e.V 35th Elite Auction of Foals and Broodmares, 21 to 23 August, 2009 terms and conditions.



3.7 Importation to Australia

Guido Klatte & Co has been engaged to import the fillies into Australia in conjunction with Crispin Bennett International Horse Transport Pty Ltd, who co-ordinate the Australian side of the importation process. Participants under this proposal have been offered the following rates and conditions:

Less than 10 weanlings:

- 4 weanlings per pallet - EUR 10,000 per weanling
- 5 weanlings per pallet - EUR 8,800 per weanling

10 or more weanlings:

- 4 weanlings per pallet - EUR 8,850 per weanling
- 5 weanlings per pallet - EUR 7,950 per weanling

The above quoted prices will include road transport from after the final inspection at the sale centre to the Lastrup quarantine, quarantine in Lastrup and the flight to Melbourne plus the 21 days post arrival quarantine in Melbourne.

NB. Number of weanlings per pallet is dictated by size of weanlings at time of shipment to maximise safety whilst in transit.

Additional Charges:

- Blood testing for EIA (Coggins test) and Piroplasmiasis (both are AQIS requirement) will be approximately EUR 100 per weanling; and
- Equine Influenza Vaccinations (AQIS requirement and necessary before weanling can go into pre-export quarantine) as per charges incurred by Guido Klatte and Co veterinarians, on behalf of the participant, per weanling.

It will not include:

1. Fuel surcharge increases
2. Any additional quarantine stay or testing due to testing problems, disease outbreak and any other reason beyond our normal control.
3. Road transport after release from quarantine in Melbourne.
4. Mortality insurance. Crispin Bennett International can arrange a quotation for this if required.
5. Any extra-ordinary veterinary fees. eg. in the event of sickness or injury whilst the horses are in the care of Guido Klatte & Co and/or Crispin Bennett International Horse Transport Pty Ltd.
6. Any farrier costs, if required.
7. Any vaccinations to be completed prior to the start of the Pre-Export Quarantine (PEQ).
8. Australian GST.
*This is payable at 10% of the horse's CIF value (Cost plus Insurance plus Freight value).
This can of course be claimed back if any of the owners are registered for GST in Australia.*
9. Carriage of gear.
10. Transfer of registration.

IMPORTANT

Increase in quarantine fees by the AQIS.

There is an increase mooted to come into effect after 1st August 2009. At this point in time, how much these increases will be, is not known. It is anticipated that AQIS will determine these costings over the next 4 to 6 weeks. Where possible the HHSA will advise participants in the proposal of the outcome.

As part of the importation process being offered a representative from Guido Klatt and Co will attend the auction to:



- Offer assistance translating and introductions;
- Organise blood testing for EIA (Coggins test) and Piroplasmosis for any fillies purchased under this proposal; and
- Organise the required vaccinations for Equine Influenza for any fillies purchased under this proposal.

3.8 Membership

Any participant in this proposal who purchases a filly foal/s under said proposal agrees to become and/or maintain the required membership status with the Hanoverian Horse Society of Australia in order to achieve the objectives outlined in 3.9.

3.9 Presentation of Filly for Classification and Performance Testing

The participant agrees to present any filly or fillies, purchased under this proposal, for classification and performance testing with the Hanoverian Horse Society of Australia as per the Hanoverian Horse Society of Australia guidelines for mare classification and performance testing (required age 3 or 4 years). The only exemption being due to death, injury or illness of the filly/fillies, upon which a veterinary certificate will be required verifying such information.

3.10 Breeding of Any Filly/Fillies Purchased

The participant who purchased any filly foal/s under this proposal agrees that the filly/fillies will only be bred to licensed and performance tested Hanoverian stallions, approved by the Hanoverian Horse Society of Australia, in order to achieve her potential Elite Mare status.

3.11 Indemnity

Any participant in this proposal shall indemnify and hold the Hanoverian Horse Society of Australia, its members, agents or servants harmless from and against:

- a) Any and all claims, demands, causes of action, damages, costs, expenses, losses or liabilities, at law or in equity, of every kind and nature whatsoever, known or unknown, arising out of or in any manner connected with any injury to any third person or persons or to the property of any third person or persons caused by the foal/s; and
- b) Any and all claims, demands, causes of action, damages, costs, expenses, losses or liabilities, in law or inequity, of every kind and nature whatsoever, known or unknown, arising out of or in any manner connected with any injury, sickness, disease, estray, theft or death to the foal/s.

3.12 Alterations and/or Changes to Terms and Conditions

This proposal, in its entirety, is subject to alteration and/or change. Where this occurs, persons who have signed and returned a “Proposal for the Importation of Hanoverian Fillies – Version 1 - 26 May 2009” document, will be notified where possible.



4. General

4.1 Summary of Actual and Potential Charges and Discounts that participants need to consider

Actual Costs and Charges

- Purchase price of a filly (including sales commission, VAT and insurance on top of actual purchase price – Refer 3.4 Condition of Sale – Foals – C. Settlement and Payment)
- Importation costs (refer 3.7 Importation into Australia)
- Vaccinations required prior to Pre-export quarantine (ie. Equine Influenza)
- Blood testing (Refer 3.7)
- Road Transport from Melbourne Quarantine to the final destination in Australia
- Goods and Services Tax (GST) payable on arrival in Australia. This is payable at 10% of the horse's CIF value (Cost plus Insurance plus Freight value)

Possible Costs and Charges

- Fuel Surcharge (Refer 3.7)
- Carriage of Gear (if any)
- Board over 21 days in PEQ & over 21 days in PAQ (if any)
- Extra ordinary veterinary care (i.e. for sickness, injury or disease)
- Transit and mortality insurance additional to that offered in Clause 3.6 (purchasers responsibility)
- Additional agistment and/or miscellaneous charges due to delays caused by, and not limited to, vaccination time frames (Refer 3.4 Condition of Sale – Foals – G. Removal and Transition of Liability)
- Additional importation costs due to delays/price increases (including any additional testing or extension of quarantine required by AQIS for whatever reason)
- Additional charges to import quarantine fees by AQIS, proposed to come into effect 1 August 2009.

Potential Discounts

The Verband have agreed that:

1. Should the collective number of fillies purchased under this scheme be 15 or more (up to 20) then the commission charged by the Verband will be reduced from 6% to 3%. Should the collective number of fillies purchased under this scheme be 20 or more then the commission charged by the Verband will be reduced from 6% to 1%. Refer 3.4 Condition of Sale – Foals – C. Settlement and Payment for further detail on the commission.

2. Transport

Less than 10 weanlings:

- 4 weanlings per pallet - EUR 10,000 per weanling
- 5 weanlings per pallet - EUR 8,800 per weanling

10 or more weanlings:

- 4 weanlings per pallet - EUR 8,850 per horse
- 5 weanlings per pallet - EUR 7,950 per horse



The above summary in 4.1 is by no means complete or exhaustive and is provided as a guide only.



1. Agreement to Participate in Proposal form – **MUST** be received by the HHS **NO LATER** than **Tuesday 30 15 June 2009**.
2. Selection of Filly Foal/s - **Single Filly Foal Bid Form** – **MUST** be received by the HHS **NO LATER** than **Monday 10 August 2009**.
This form is for people who wish to bid on ONE filly only.
3. Selection of Filly Foal/s - **Multiple Bid Form** – **MUST** be received by the HHS **NO LATER** than **Monday 10 August 2009**.
This form is for people who wish to try and secure more than one filly.
4. Selection of Filly Foal/s - **Preference Bid Form** - **MUST** be received by the HHS **NO LATER** than **Monday 10 August 2009**.
This form is for people who wish to secure one filly only but have a selection of preferences to “fall back on” should they miss out on their 1st or 2nd preferences. NB. Obviously, for bidding purposes these preferences will have to be listed in numerical order, as they appear in the catalogue.
